I am happy to inform you that BharatNet, one of the largest rural broadband projects of the world, is being implemented for providing broadband connectivity to all the Gram Panchayats of the country. It is imperative that the BharatNet infrastructure should be utilised to provide maximum number of services in rural areas by the Ministries/Departments.

- 2. In the Budget speech of the year 2020, it was also announced that FTTH (Fiber to the Home connections, i.e. high speed broadband on OFC) in 1 lakh GPs, through BharatNet, will link public institutions for delivery of e-Governance services. In pursuance of the above, CSC e-Governance Services India Ltd (a Special purpose vehicle of Ministry of Electronics & Information Technology, Government of India) has been assigned the implementation of the above task. The installation of the FTTH at the 5 Government institutions per GP is free and no User charges are to be paid for the first year. So far about 3.28 lakh FTTH connections have been provided in Government Institutions.
- 3. Recently, Secretary (T) chaired a meeting on 17.11.2020 with the concerned Ministries/Departments regarding utilisation of BharatNet broadband infrastructure and enhancing the bouquet of services in rural areas. Prior to the above meeting, on 21.08.2020, I had convened a meeting of a Committee having Joint Secretary level Members from the User Ministries/Departments in this regard wherein it was decided that the concerned Ministries/Departments will issue necessary instructions to sensitize their counterparts in the States.
- 4. Accordingly, I request for the following:
 - i. Expediting the utilization of BharatNet broadband network by offering maximum number of services through broadband in rural areas.

- ii. Providing the details of the services that can be offered on BharatNet Network, as already requested vide this office letter of even No. dated 28.12.2020.
- iii. The State Governments be advised to take FTTH connections under the above scheme for the relevant public institutions under your Ministry/Department.
- iv. Identifying/Designating a Joint Secretary level officer in your Ministry/Department to coordinate with Department of Telecommunication for providing FTTH connections under BharatNet for the identified public institutions at GP level (if not done so far).
