- 5. The Central Assistance shall be utilized within a period of two years from the date of this sanction order and on the activities contained in the guidelines of the scheme.

- 7. As per the instructions contained in Ministry of Finance, Department of Expenditure's Circular No. 7 (1) E. Coord/2008 dated 5.6.2008, no amount shall be released to any State which has defaulted in furnishing Utilization Certificates for grants-in aid release by the Central Government in the past. It is certified that no UC is pending under this scheme against the above State Government.
- 8. The State Government would ensure that the guidelines as issued by the Department of Expenditure, Ministry of Finance with regard to revised procedure for flow of funds under Centrally Sponsored Schemes by adopting SNA and subsequent instructions are followed.
- 9. The accounts will be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act, 1971and internal audit by the Principal Accounts Office of the Ministry or Department whenever the institution or organization is called upon to do so.
