Subject: - Release of Central Assistance under the Adarsh Gram Component under the Centrally Sponsored Scheme of PM AJAY to the Govt. of Tamil Nadu for the year 2024-25 -reg

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 190,87,66,000/- (Rupees One Hundred and Ninety Crore Eighty Seven Lakh and Sixty Six Thousand only) as 4th Installment to State Govt. of Tamil Nadu under Adarsh Gram component of PM-AJAY** scheme during 2024-25 as Central Assistance under the Adarsh Gram component of Centrally Sponsored Scheme of Pradhan Mantri Anusuchit Jaati Abhyuday Yojana (PMAJAY) for the villages selected since 2018-19 (including the villages selected in 2022-23 as per 40% SC criteria) for implementation of scheme for the year 2024-25.

2. The amount is debitable to the Major Head "3601"; Grants-in-aid to State Governments (Major Head); 06-Centrally Sponsored Schemes (Sub Major Head); 789 – Special Component Plan For Scheduled Castes (Minor Head); 34.12- Pradhan Mantri Anusuchit Jaati Abhyuday Yojana(PM AJAY); 34.12.31- Grants-in-aid-General; Demand No.93 of the Ministry of Social Justice & Empowerment for 2024-25 (Plan), a component of Pradhan Mantri Adarsh Gram Yojana (PMAGY) under the scheme of Pradhan Mantri Anusuchit Jaati Abhyuday Yojana (PMAJAY).

3. Arrangements may please be made to credit this amount to State Government in accordance with the procedure laid down in the Ministry of Finance O.M. No. 2(45)/76 Special Cell, dated 30.8.1976, as modified vide O.M. of even number dated 16.09.1976 under intimation to us.

4. The sanction of the above Central Assistance amounting to **Rs. 190,87,66,000/-** under the scheme is for undertaking the 'gap-filling' activities as well as incurring administrative expenses during the course of implementation of scheme as per the scheme guidelines.

5. The Central Assistance shall be utilized within a period of two years from the date of this sanction order and on the activities contained in the guidelines of the scheme.

6. The State Government would update the relative progress in respect of implementation of the scheme and utilization of the Central Assistance through the online MIS portal developed for the purpose.

7. As per the instructions contained in Ministry of Finance, Department of Expenditure's Circular No. 7 (1) E. Coord/2008 dated 5.6.2008, no amount shall be released to any State which has defaulted in furnishing Utilization Certificates for grants-in aid release by the Central Government in the past. It is certified that no UC is pending under this scheme against the above State Government.

8. The State Government would ensure that the guidelines as issued by the Department of Expenditure, Ministry of Finance with regard to revised procedure for flow of funds under Centrally Sponsored Schemes by adopting SNA and subsequent instructions are followed.
