Subject:- Release of Central Assistance under the Centrally Sponsored Scheme of Pradhan Mantri Adarsh Gram Yojana (PMAGY) to the Government of Andhra Pradesh for the year 2020-21-reg.

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 23,80,00,000/-** (Rupees Twenty Three Crore Eighty Lakh Only) to the **Government of Andhra Pradesh** in respect of 150 villages selected in 2020-21:

- a) 1st Installment of 150 villages @10.80 lakh per village = 1620.00 lakh.
 - b) 2nd Installment of 76 villages out of 150 villages @ Rs. 10.00 lakh per village=760.00 lakh.
2. The amount is debitable to the Major Head "3601"; Grants-in-aid to State Government (Major Head); 06-Grant for State Plan Scheme (Sub Major Head) ;789 – Special Component Plan For Scheduled Castes (Minor Head); 34.09- Pradhan Mantri Adarsh Gram Yojana ; 34.09.31- Grants-in-aid-General; Demand No.92 of the Ministry of Social Justice & Empowerment for 2020-21(Plan).
 3. Arrangements may please be made to credit this amount to State Government in accordance with the procedure laid down in the Ministry of Finance O.M. No. 2(45)/76 Special Cell, dated 30.8.1976, as modified vide O.M. of even number dated 16.09.1976 under intimation to us.
 4. The sanction of the above Central Assistance amounting to **Rs. 2380.00 lakh** as under the scheme is for undertaking the 'gap-filling' activities as well as incurring administrative expenses during the course of implementation of scheme as per the Scheme Guidelines.
 5. The Central Assistance shall be utilized only as per the provisions contained in the guidelines of the scheme.
 6. The State Government shall furnish online quarterly progress reports in respect of implementation of the scheme and utilization of the Central Assistance to this Ministry through the online MIS portal developed for the purpose.
